## Parking Parking Parking Lawn Parking Ordinance

The Lawn Parking has passed on second reading only at council. It is scheduled for third reading in late August. There may be revisions but I have not seen any yet. I doubt revisions will be in time for the newsletter. I am told they are minor changes. If it is revised, we will need to vote again. I think the next vote should be on the "spirit" of the agreement. We voted on a substitute motion at the February meeting to take "no action" until the language of the ordinance firmed up. We then voted in June to be included in the ordinance, but limited our acceptance to the revision (#8) that was in place at that time. Since the language looks like it will have some minor changes we'll need to vote again. I mentioned this might be necessary at the June meeting. Council could have passed it on second and third reading this last time and that is why we needed to decide in June. To make a motion or vote, you must be a member of the association at least 10 days prior to any vote. Current bylaws do not allow proxy Remember, that our bylaws were revised in June to allow membership even if you cannot pay dues. With or without paying dues, you must still fill out a membership form and join the association to vote (just like Travis county, although they require you to register 30 days before an election). More information on this ordinance can be obtained from the sponsor of this ordinance, Council member Thomas' office.

#### **Neighborhood Development updates:**

The Shamrock gas station property on Lamar at Kinney sold. The spokesperson for Shamrock told me that it had not closed yet and he could not reveal the buyer yet. He did tell me that it would not be a gas station anymore and deed restrictions would be put on the property to insure that. As you have probably already noticed, the tanks have been pulled and they are doing a "closure" of that as an underground storage area. He said that Lamar Storage was not the buyer.

As far as Lamar storage goes, I have not heard anything from the developer or his agent in many months.

Russell's Bakery continues to try to open the café/bakery on Lamar where Anna's Toy Depot once was. I spoke with Russell a few days ago and he was about to throw in the towel on the whole thing. The city has been giving him a very difficult time. It seems that the lot is zoned CS on half and SF-3 on the other, although it has always been used as commercial property. He is going to try a bit more to make it work. He told me he wanted to do something a little upscale. Sounds like a pleasant change from another used car lot?

Nothing new to report about the two projects on Thornton. Many rumors and overtures but I have not heard anything official yet and have not had contact with the owners of either property.


